I INTENDED TO TELL THE DOCTOR THE NEXT MORNING THAT I WAS LEAVING AND GOING HOME. I MADE A JOKE THAT I THOUGHT THEY WERE TRYING TO KILL ME. LITTLE DID I KNOW THAT MY JOKE WAS PRETTY MUCH ON TARGET.

SATURDAY MORNING WHEN THE DOCTOR CAME TO CHECK ON ME, I TOLD HER I WAS CHECKING OUT AND GOING HOME. SHE TOLD ME I COULDN'T LEAVE AS I STILL HAD TWO MORE DAYS OF TREATMENT I NEEDED TO TAKE. I TOLD HER I DIDN'T CARE WHAT SHE THOUGHT AND THAT I WAS LEAVING WITH OR WITHOUT HER APPROVAL. WE ARGUED FOR SEVERAL MINUTES WITH HER FINALLY RECEIVING AND SAYING SHE WAS GOING TO CALL IN A PRESCRIPTION THAT SHE WANTED ME TO PICK UP AND TAKE. I HAD NO INTENTION OF TAKING ANYTHING SHE PRESCRIBED AND DIDN'T PICK IT UP.

ONCE WE GOT HOME, MY WIFE WAS GOING THROUGH THE HOSPITAL PAPERWORK AND SAID IT SHOWED THAT I WAS IN STAGE 3 KIDNEY FAILURE. SHE WENT BACK TO WHEN I WAS ADMITTED, AND IT SHOWED THAT MY KIDNEYS WERE FINE AT THAT TIME. SO, WE STARTED LOOKING AT WHAT THEY HAD GIVEN ME AND RESEARCHING THE DRUGS.
